#### 1. Why are you interested in serving on the Board of Directors of the Co-op?

My first experience at Black Star Co-op was during Barks for Beers 2021 and was immediately sold by the worker-focused model, care for community and passion for quality beer! Long-term, I'd also like to see Black Star continue the tradition of brewing excellence by winning some more medals at the Great American Beer Festival, Texas Craft Brewers Association, and existing as a welcoming space for craft beer enthusiasts!

## 3. What qualities and past experience do you have for serving on the Black Star Co-op Board of Directors?

I have an acute eye for detail as an engineering PhD student, which lends itself to well thought out plans. I have also served on industrial relations for the UT chemical engineering PhD student organization, and was successful in securing funding and partnerships from a variety of global corporations, so I understand
